

ILLINOIS DEPARTMENT OF LABOR ORDINANCE

Whereas, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works", approved June 26, 1941, as amended, being Chapter 820 ILCS 130/1-12, Illinois Compiled Status; and

Whereas, the aforesaid Act requires that the Carlinville School District investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Carlinville School District employed in performing construction of public works, for said Carlinville School District; and

Now therefore, be it ordained by Dr. Becky Schuchman, Superintendent, Carlinville School District, Macoupin County, Illinois as follows:

SECTION 1

To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works" approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of this Carlinville School District is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Macoupin area as determined by the Department of Labor of the State of Illinois as of June 2018, a copy of that determination being attached hereto as Exhibit "A" and incorporated here by reference. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

SECTION 2

Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works and landscaping construction of this Carlinville School District to the extent required by the aforesaid Act.

SECTION 3

The Superintendent shall publicly post or keep available for inspection by any interested party in the main office of the Carlinville School District this determination of such prevailing rate of wage.

SECTION 4

The Superintendent shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.


SECTION 5

The Carlinville School District shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

SECTION 6



PREVAILING WAGE RATES
