What does ROE #40 do?

Regional Office of Education #40 has two offices providing services to school districts, educators and the public in Calhoun, Greene, Jersey and Macoupin counties. Under the direction of Superintendent Michelle Mueller and Assistant Superintendent Chad Hoesman, staff duties in the Carlinville and Jerseyville offices consist of more than the normal clerical and bookkeeping.

The ROE is an essential support office partnering with the Illinois State Board of Education. Staff keeps current on changes to educator licensing to assist educators with applying for and renewing licenses. We also work with our 14 districts to assure schools are in compliance, giving our students safe, healthy learning environments. The ROE manages 3 alternative education sites and 3 adult education programs for our region.

Trained staff members register students for work permits and home schooling, provide GED transcripts, distribute sales tax to the school districts, coordinate training for school bus drivers, coordinate special events like spelling bees, Olympiad and Institutes. ROE #40 provides a large variety of professional development opportunities for educators. Our offices are authorized Pearson Vue test centers, and all of our office staff are certified test administrators. Hundreds of tests are offered including GED, TAP, CompTIA, CHRMP, etc. Another service provided is live scan fingerprinting for school staff, health care workers, and more.

(Reminder: Public School Works is not considered approved PD).

WANTED: Short-term Subs

What is a short-term substitute?

Public Act 100-0596:

- Applicants for a Short-Term Substitute Teaching License must hold an associate's degree or have completed at least 60 credit hours from a regionally accredited institution of higher education
- An individual holding a Short-Term Substitute Teaching License may teach no more than 5 consecutive days per licensed teacher who is under contract.
- An individual holding a Short-Term Substitute
 Teaching License must complete the training program
 prior to working as a substitute teacher.
- All Short-Term Substitute Licenses will expire on June 30, 2023.

Short-Term Substitute Teacher Trainings will be offered at ROE #40 each month. Trainings will be held in the mornings 8:30 -11:30. Q&A Events on Flexibility to Define Instructional Days Locally

School districts in Illinois now have maximum flexibility to define instructional days based on what will improve outcomes for students. The Illinois State Board of Education will host a series of public Q&A events for educators, parents, families, and school and district leaders to ask questions and share successes and challenges in using this flexibility afforded in state law.

Public Act 100-0465, also known as the Evidence-Based Funding for Student Success Act, made sweeping changes to education funding in Illinois when it became law on Aug. 31, 2017. The law changed the basis of state funding to student enrollment, rather than attendance. The act removed Section 18-8.05 of the School Code, which had defined a day of attendance as a minimum of five instructional hours. Funding schools on enrollment provides school districts the resources and flexibility to support all students, especially the students most in need of support to access educational opportunities.

Students learn in a variety of ways and settings. ISBE encourages districts, school boards, and collective bargaining units to work together to innovate new ways of teaching and learning that center on competencies and mastery of subject matter – anywhere and anytime.
