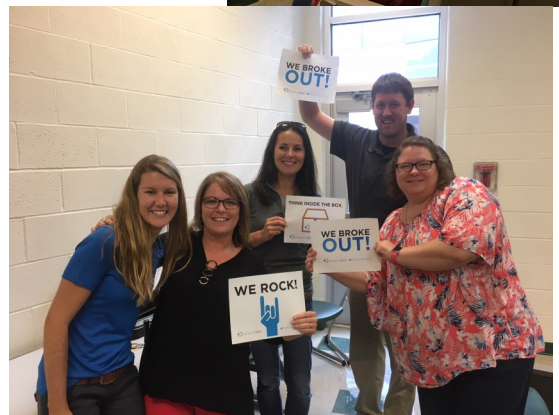
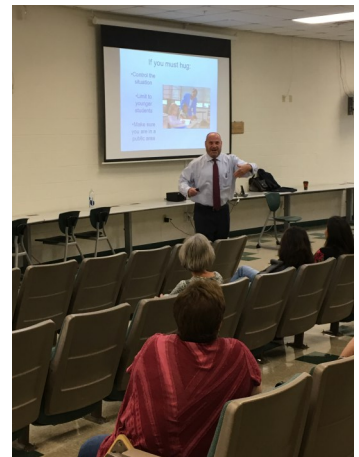
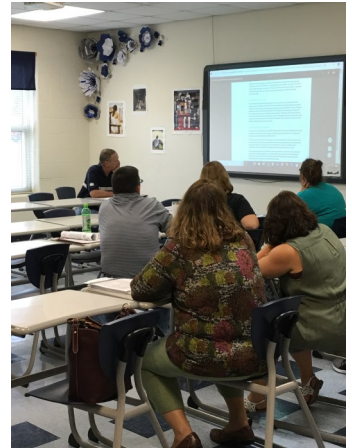
ROE #40 2018 Institute Wrap-up

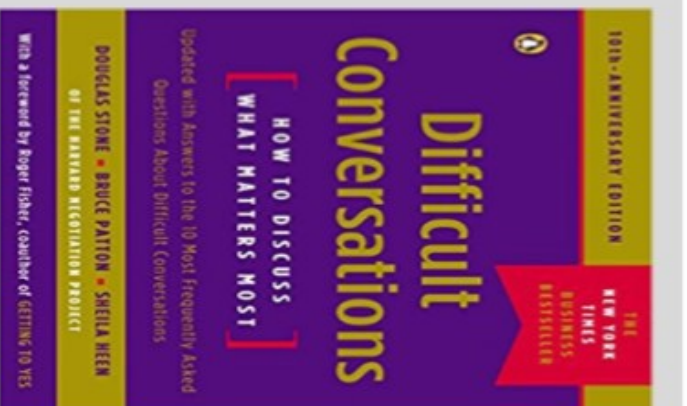

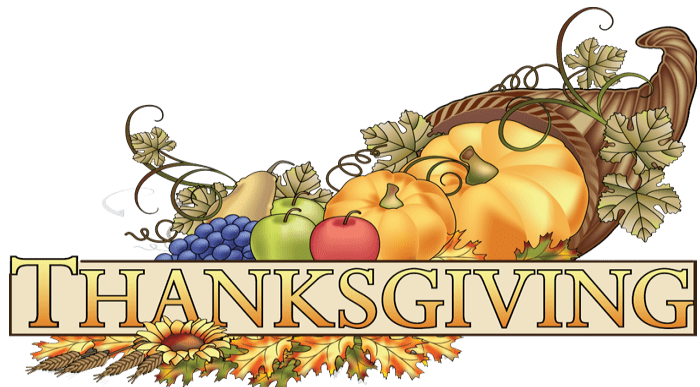

High School CPR Toolkits Available to our Schools

Lauren's Law, enacted in July 2014, requires that all secondary schools provide training in Bystander CPR and Automated External Defibrillators (AED) education as part of the health education curriculum. The Illinois State Board of Education provides a guidance document on this law, available at www.isbe.net/pdf/school_health/guidance-15-06-CPR-AED-secondary-schools150801.pdf.

To help schools with the cost and materials necessary to meet this requirement, Illinois Heart Rescue has created High School CPR Toolkits for schools' use. Each toolkit will include 16 stackable and durable mannequins, two AED trainers, educational support materials including key messaging highlights, and reference materials. Each kit also contains a CPR training DVD that is available in five languages.

Regional Offices of Education (ROEs) via the Illinois State Board of Education will house the CPR toolkits. Individual schools will be able to "check out" the CPR High School Toolkits as needed through the ROEs.

The Carlinville ROE has the kits available for check out to all of the schools within our district at no cost. Please contact the Carlinville ROE office at 217-854-4016 if you would like to schedule training for your high school students.

Arts and Foreign Language Implementation Assistance Grant

The Illinois Arts Council Agency and the Illinois State Board of Education are pleased to announce funding is available for school districts and other eligible applicants in FY 2019 for the Arts and Foreign Language Implementation Assistance Grant.

The Illinois Arts Council Agency has released a Request for Proposals (RFP). The purpose of the RFP is to solicit proposals from eligible applicants that are seeking resources to introduce or expand instruction in the arts or foreign language, as applicable, and for developing means of perpetuating the funded program with local resources after the conclusion of the anticipated three-year grant cycle. Annual grant awards will not exceed \$100,000 depending on the programmatic needs, size of district, and level of implementation proposed. Full guidelines and materials can be found on the Illinois Arts Council Agency's [Arts and Foreign Language Education Grant Program](http://www.arts.illinois.gov/AFL). Proposals are due **Wednesday, Dec. 12, 2018**.

An online, informational webinar about the Arts and Foreign Language Implementation Assistance Grant, designed to provide technical assistance on the RFP and answer questions about the process, is scheduled for 1 p.m. on November 8. Registration information is posted on the Illinois Arts Council Agency's [Arts and Foreign Language Education Grant Program](http://www.arts.illinois.gov/AFL).

Breakfast After the Bell Grants

No Kid Hungry offers Breakfast After the Bell grant opportunities in Illinois. Grants support schools with the purchase of approved equipment, materials, and initiatives that facilitate Breakfast After the Bell delivery models in an effort to increase student participation in breakfast.

Applying schools must either be implementing or be prepared to implement a Breakfast After the Bell delivery model, such as Breakfast in the Classroom, Grab and Go, and Second Chance Breakfast. Individual schools may apply for up to \$5,000.

Subject to funding availability, No Kid Hungry has two remaining grant rounds with the following due dates: **Nov. 16 and March 4**. To complete an application, you will need a detailed budget outline of the grant request; key strategies you have taken/plan to take to implement your program and anticipated challenges; the breakfast model you plan to implement, the anticipated start date, and where you will serve meals; school level breakfast and lunch data for the month of October and total school enrollment; and contact information.
