

FREE SUICIDE PREVENTION TRAINING FOR ILLINOIS SCHOOL STAFF



With funding from the Illinois State Board of Education, the Illinois Department of Public Health (IDPH) is offering courses to train anyone working in an Illinois K-12 school on suicide prevention. IDPH is pleased to partner with the ECHO-Chicago program at the University of Chicago to host the trainings.

School Support Personnel (social workers, counselors, psychologists, nurses)

Assessing and Measuring Suicide Risk (AMSR)

Training - 6.5-hours of material. There are two options for this training - asynchronous and virtual.

- Option 1 asynchronous/self-pace course available on demand. Register by March 1, 2024.
- Option 2 virtual training available on (select one)-
 - Wednesday, February 21 from 8a-4p (registration deadline 2/7/24).
 - Friday, February 23 from 8a-4p (registration deadline 2/9/24).
 - Tuesday, February 27 from 8a-4p (registration deadline 2/13/24).
 - Thursday, February 29 from 8a-4p (registration deadline 2/15/24).

The Illinois State Board of Education kicked off 2024 with three major approvals at its January Board meeting last week. First, we approved the Illinois Comprehensive Literacy Plan – the result of more than a year of engagement with educators and stakeholders all over the state. The plan does not advocate for or include any new mandates for districts. Rather, it guides districts through evaluating your own data, curricula, and instructional practices for alignment to evidence-based best practices and then making shifts to support students.

The plan is packed with evidence-based resources to give every educator tools for cultivating strong literacy skills in all learners. Designed to be interactive, it features workbook-style pages for a variety of audiences. We have several resources forthcoming to support your implementation of the plan, including a rubric for evaluating literacy curricula, a template to support you in developing local districtwide literacy plans, and guidance on training and deploying literacy coaches.
